Exposure for your group – The **Denver Christkindl Market** attracts people from around the greater Denver Metro Area, Colorado and beyond during its operation. Where possible, performer's names and likeness may be included in any and all forms of publicity or advertising at the discretion of the Denver Christkindl Market. By signing this application you authorize the Denver Christkindl Market to use your likeness, image or audio in its publicity and marketing on a non-exclusive basis for the 2011 and future Denver Christkindl Markets.

The Denver Christkindl Market intends to select a variety of entertainment that will reflect the holiday season. A group's cost, availability, genre, talent and appeal will all be taken into consideration when selecting the performances.

We encourage all varieties of entertainers to apply. The market strives to reflect and entertain our culturally diverse population of Colorado.

Production – There are two stages; one is under a tent, where performers will be scheduled throughout the event. While a public address system will be available, performers are encouraged to bring their own sound systems to ensure desired quality. However, we do NOT provide a sound engineer/mixer.

Expectations – even if you have applied or performed at the Denver Christkindl Market in the past, you still need to submit an application with performance samples, and reflect the prior performance on the application.

All applications must be delivered no later than **September 25, 2011**. Submit each group separately. We will notify you within 14 days of our decision.

The Denver Christkindl Market will not be responsible for incomplete applications. Incomplete applications will not be considered. Any and all materials included with your application will become property of the Denver Christkindl Market and will not be returned.

All entertainment must be suitable for a family audience.

Because of limited resources, musicians/performers at the Denver Christkindl Market are generally not paid a fee. However, we offer promotional support and other perks to compensate. In return for your time and energy your band/performance will receive the following:

- a. Band/performance name (and digital photo if provided) will be listed on our website along with links to your website.
- b. Your band will be listed on the entertainment schedule in the event map along with your time and venue location.
- c. You may sell CDs and distribute promotional materials. You are also welcome to have a mailing list sign-up sheet available during your performance.
- d. A tip jar/receptacle in the stage area is acceptable.
- e. Advertising or materials may be made available at the stage or stage area.
- f. All banners or promotional material must be approved in advance; and the Denver Christkindl Market reserves the right to have any such items removed at any time before, during or after a performance.
- g. Light hospitality will be offered light hospitality gratis.

While we will make every effort to provide a comfortable environment for the performers, bear in mind the performance is outside during the winter. Vehicles are allowed only in designated nearby parking areas, and you will need to provide your own roadies or grips.
